REGULATIONS

1. These regulations may be cited as the regulations under Pawnbroker's Statue of the Western Provincial Council No. 01 of 2015
2. The following fees and deposit should be charged on Pawn Broking Business under Sub section 7(3) and 9(2) of this statute,

Description	Fee Rs.
a. Registration of Pawn Broking Business	25,000/-
b. Annual License fee payable for Pawn Broking Business	5,000/-
c. Amount of security payable by Pawn Broking Business holder	100,000/-

3. Security deposit shall be credited only to a deposit account of People Bank, Bank of Ceylon and National Savings Bank.
