Western Province Provincial Council Financial Amendment Statute No. 02 of 2006

ORDER UNDER SECTION 98(3)

BY virtue of the powers vested in me under Section 98(3) of the Financial Statute No. 02 of 2006 Western Province Provincial Council, I, Pestheruwe Liyanaralalage Reginold Rosmand Cooray Wijewarnasooriya, Chief Minsiter and Minsiter of Finance, Planning, Law and Order, Local Government, Provincial Administration, Education, Transport, Employment, Cultural and Art Affairs of the Western Provincial Council, do by this order, amend with effect from the 15th April, 2008.

REGULATIONS

These regulations (Imposition of Tax on Prize competitions) may be cited as the regulation of Western Province Provincial Council Financial Amendment Statute No. 02 of 2006 Order under Section 98(3)(i)(ii)(iii)(iv).

I. A prorate tax shall be charged on the total value of the prizes awarded at every prize competition held within the Western Province calculated in the following manner:

Total value of the prizes	Pro Rate Tax	
Less than Rupees One Hundred Thousand	Exemption	
Rupees Twenty Five Million (Rs. 25 m) or less	3%	
More than Rupees Twenty Five Million (Rs. 25 m)	5%	

- II. (a) The Licence shall be in the form set out i.e. Schedule "B".
 - (b) The application for a licence shall be in the form set out in Schedule "A" hereto and shall be accompanied by a fee of Rupees One Thousand (Rs. 1,000/-) in cash.
 - (c) The following documents shall be submitted together with the application for a licence, namely-

- (i) The Certificate of Registration of the applicant (if the applicant is an Institute or an Organization) and a certified copy of such Certificate.
- (ii) The approved document which contains the rules or conditions as the case may be, applicable to the prize competition together with certified copies of such documents and a full and accurate description of the prize to be awarded at such competition.
- (iii) A receipt or any other document in proof of payment of the licence fee.
- III. Place or Premises where a Prize Competition can be conducted or promoted under this statute shall be announced.
- IV. The return i.e. Schedule "C" as mentioned in section 98 (3) of the Financial Statute shall be submitted to the Provincial Commissioner of Revenue.

In these Regulations "Financial Statute' means the Financial Statute No. 6 of 1990 of Western Province Provincial Council as amended by Statute No. 2 of 2006 of such Council.
